

**FACTS****WHAT DOES Mortgage Master Service Corporation DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

§ Social Security Number	and Mortgage rates and payments
§ Assets	and Income
§ Credit history	and Payment history

**How?**

All financial companies need to share **Customers** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **Customers** personal information; the reasons **Mortgage Master Service Corporation** chooses to share; and whether you can limit this sharing.

How does protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p><b>We restrict access to non-public personal information about you to those employees who need to know that information to provide products and services to you.</b></p>
How does collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>§ <b>Apply for a loan</b> or</li> <li>§ <b>Give us your contact information</b> or</li> <li>§ <b>Give us your employment history</b> or</li> <li>§ <b>Give us your income information</b> or</li> <li>§ <b>Show your driver's license</b></li> </ul> <p><b>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies</b></p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>§ sharing for affiliates' everyday business purposes — information about your creditworthiness</li> <li>§ affiliates from using your information to market to you</li> <li>§ sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>§ <i>Mortgage Master Service Corporation We do not have affiliates</i></p>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>§ <i>Mortgage Master Service Corporation We share personal information with nonaffiliated third parties Title and Escrow Companies, Appraisal Companies, etc.</i></p>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p>§ <i>Mortgage Master Service Corporation We do not engage in joint marketing</i></p>
